Performance and Analysis

Business Performance Summary

The Company had total revenue for the three-month periods ending September 30, 2024 and 2023 of 117.71 million baht and 79.99 million baht, respectively, which increased by 19.71 million baht or 20.12 percent from 2023 because the three-month period ending September 30 had revenue from services of 12.64 million baht, an increase of 0.69 million baht or 5.84 percent from the same period of the previous year, including revenue from electricity sales that increased for the three-month period ending September 30, 2023 by 53.44 million baht, an increase of 20.47 million baht or 62.08 percent.

The Company had total expenses for the three-month periods ending September 30, 2024 and 2023 of 73.43 million baht and 60.24 million baht, respectively, an increase of 13.19 million baht or 21.90 percent.

For the three-month period ending September 30, 2024, the Company had a net profit of 42.95 million baht, an increase of 4.94 million baht or 13.02 percent from the three-month period ending September 30, 2023.

The Company has total assets for the three-month period ending September 30, 2024 of 6,394.58 million baht, a decrease of 409.22 million baht or 6.01 percent from the previous year.

The Company has total liabilities for the three-month period ending September 30, 2024 of 2,144.01 million baht, a decrease of 296.20 million baht or 12.14 percent from the previous year. This is due to a decrease in short-term loans and accrued interest - other businesses of 109.76 million baht, as well as a decrease in long-term loans from financial institutions of 167.92 million baht.


Risk Management Policy


